**Excavation of Mineral Sands from Lands Adjacent to Poduwakattu Coastal Strip, Transportation of Excavated coarse Mineral Sands to Pulmoddai Plant and transportation of the washed sand removed from the plant to Poduwakattu and Re-filling of Excavated Lands**

Quotations are hereby invited from individuals and institutions owning legally entitled lands located within 100 meters from the Poduwakattu coastal strip (within the areas where Lanka Mineral Sands Limited holds legal excavation permits) for the requirement of excavating heavy mineral sands from lands adjacent to the Poduwakattu coastal strip along the Pulmoddai-Trincomalee road, transporting the excavated mineral sands to the Pulmoddai plant of Lanka Mineral Sands Limited (operating under the Ministry of Industries and Enterprise Development) and transporting the washed removed sand back to Poduwakattu from the plant, and re-filling the excavated lands. Tenders will be called under the National Competitive Bidding (NCB) procedure.

2. Tender documents can be purchased upon payment of a non-refundable fee of **Rs. 20,000/-** from the above-mentioned Supply Division office or from the Pulmoddai Plant between **13.10.2025** and **02.11.2025** up to **2:30 p.m.** on the final day.
3. Sealed tenders must be sent by registered post to the below-mentioned address or deposited in the tender box available at the same address, to be received on or before **2:30 p.m. on 03.11.2025**. The original and duplicate copies of the tender must be separately enclosed in sealed envelopes, and then both envelopes must be enclosed in a single sealed envelope. Late tenders will be rejected. Tenders will be opened immediately after the closing time in the presence of bidders or their representatives who choose to attend.
4. A refundable **Bid Security of Rupees One Hundred Thousand (Rs. 100,000/-)** must be submitted along with the bid. The bid validity period shall be until **02.02.2026**.
5. A **pre-bid meeting** for eligible bidders will be held at the **Pulmoddai Plant Auditorium at 2:00 p.m on 22.10.2025**.
